Other Business - incl. Member questions and comments.

There were member questions and comments, summarized as:

- Members would prefer e-transfers for payment, rather than cheques.
- Why does the WGHA not have more logo products available on-demand with a requirement to order in advance.
- How can WGHA boost goalie #s for U18 house league?
- Why does U18 not have practices in addition to the two weekly games?
- There should be a review of goalie and player import rules for representative teams, as too many WGHA players are leaving to play in other leagues.
- Coach conduct should be monitored more closely by Board and infractions should be treated more seriously.
- The WGHA should do more to protect young female referees from verbal abuse by coaches and players
- There should be an enforceable code of conduct for team bench staff
- WGHA should maintain the current logo throughout the term of the current clothing RFP.
- The board explained that WGHA has non-parent paid coaches for the U13AA, U15AA and U18AA and U22AA (Jr Elite) teams.

The WGHA had another successful year and one without any disruptions which has not happened since the 2018/19 season.

18 Representative teams were iced again this season with many successes along the way in tournament play and large number of teams qualifying for both League playoffs/Provincial Playdowns and Provincial/League Championships. This season saw again many Rep teams involved in mentoring younger teams and continued community involvement initiatives such as Feed the need and the CIBC run for the cure.

Thank you to our Town of Whitby partners for continuing our Iroquois Park Pad 1 dressing room agreement as well as the requested improvements to give our High Performance Jr Elite Program a dedicated space to call their own that will continue to attract skilled players to the WGHA. Also, we appreciate the hanging of our Rep team Championship banners and the ongoing cooperation with ice scheduling requests.

A few of the processes that the board implemented this season included the following:

- 1) Rep and DS Coach commitment letters and executive board members code of conduct implemented.
- 2) Financial regulation for Rep and DS teams with Realtime Online Budgets using CRA rates and uniform agreed on compensations for HPP teams staff.
- 3) Standardized Rep Coach interviews process implemented for the 2025-26 season.
- 4) House League coach support and mentoring

Thank you to our WGHA families for their support in allowing the WGHA to run a successful 2024-25 Hockey season and for the privilege of providing girls in Whitby a community space to raise strong, confident girls.

House League Directors Report

The 2024–2025 season was a success. In partnership with the VP of House League, we focused on enhancing both player development and coach support across the U11–U15 age groups.

One of our major initiatives was working alongside Scary Skate to develop and implement structured practice plans to guide the majority of the season. These plans provided consistent, high-quality development opportunities across the divisions. In addition, Scary Skate was on the ice twice a month with U11–U15 teams to support coaches, offer feedback, and help ensure players were receiving strong technical instruction throughout the year.

As part of our player development program, we ran DS (Development Stream) teams in U11, U13, U15, U18. Our DS teams had very successful seasons, with multiple semi-final tournament finishes, a Championship finish for the U15 DS team in the Oshawa tournament.

Championship Weekend was an overwhelming success. Thank you to Tanya McPherson, Director, Jr House League, who led the planning and execution of our Championship Weekend. From puck drops by Mayor Elizabeth Roy to photo booths, tattoos, WGHA merch and a weekend filled with exciting hockey games, it was a weekend the athletes won't soon forget!

The top House League teams from U11 - U18 also participated in the Queen of the Rink tournament - a great way to end the season!

We also delivered another successful 12 week *First Shift* program, welcoming 46 new participants to our association. This program was led by an all-female coaching staff made up of 10 coaches, 6 current Wolves players and 4 up-and-coming coaches. Their leadership not only created a great experience for the players but also reinforced our commitment to growing female leadership in sport.

Thank you to all of our volunteers, coaches, convenors, and families for their support and dedication this season. We look forward to continuing to build on these initiatives in the year ahead.

Annual General Meeting Report Director of Trainers, WGHA May 29, 2025

As the Director of Trainers for the Whitby Girls Hockey Association (WGHA), I am pleased to present my report, highlighting key initiatives and responsibilities undertaken in preparation for the 2024/2025 season.

1. Monthly Communication & Injury Reports

Established a streamlined communication protocol that mandates monthly check-ins with our trainers. Furthermore, I requested regular injury reports to stay informed about the health and safety of our athletes, ensuring timely interventions where necessary.

2. Liaison with OWHA for Claims

In my role as the intermediary between parents and the Ontario Women's Hockey Association (OWHA), I assisted in the claims process for injuries. This vital connection ensured that our trainers and athletes received the necessary support during challenging circumstances.

3. Scheduling Coordination for Tryouts

I took an active role in attending and coordinating the schedule for trainers during tryouts, guaranteeing there were no conflicts of interest. It was mandated that all trainers be rostered with WGHA and not be a family member of any skater attending the tryout. Additionally, I provided trainer kits for those in need during the session(s) to ensure they were adequately prepared.

4. Virtual Meeting with House League Trainers

Alongside the Junior House League Director, I participated in a virtual meeting to welcome our house league trainers. This initiative aimed to foster a sense of community and shared objectives among our trainers, strengthening the operational cohesiveness across all divisions.

It has been a productive year, filled with challenges and opportunities for growth. I look forward to continuing to serve the WGHA and enhancing the support we offer to our trainers and athletes alike.

The tournament of heroes was yet again a very successful event bringing in 120 teams across Ontario participating among 17 divisions. The tournament generated close to \$40K in profits to the association. I wouldn't have been able to successfully deliver this tournament if not for my fellow board members, volunteers, tournament organizers, referees, time keepers, town and rink staff.

Apart from the tournament I have also been oversight to the association financials as well as the Junior Wolves team as the secondary signatory on the team account. While the association is continuously improving on transparency and integrity on every process related to members and their activities. We are also striving to reduce barriers to entry to the community by organizing various events at Play in Whitby day etc. The board itself cohesively works well together in achieving a common objective and that is to keep our players first in every decision that is taken at the board level. I wish everyone a very successful year ahead as well as a well deserved and much needed summer break.

Just a note to thank the Board for their support during the 2024/25 season. We had a number of incidents which resulted in suspensions, but in all it was a very good season. We had 19 new officials join our officiating team and look forward to adding more for the 2025/26 season. I have sent out notification inquiring as to how many officials will be returning. I would also like to thank Bruce and Ryan for scheduling the tournament and for scheduling both the house league and 2 person system as games arise. Bruce has acted as a monitor for the younger officials, and I joined the OWHA as an Officiating Coach this past January working primarily with our more seasoned referees. The younger officials have been very positive regarding the feedback from Bruce and noticeable improvement has been evident. Again thank you and we will see you at the rink.

- Advised on policy updates and contributed to board discussions to ensure that an equity lens informs organizational priorities and decisions.

4. Community & Member Engagement:

- Assisted in the planning and execution of WGHA-hosted events, ensuring that DEI considerations were integrated into event design and delivery.
- Provided ongoing DEI guidance and hands-on support to board members across various operational areas.

- 6. We should have received or will receive a cheque from Roy's for their sponsorship. It will be approximately \$3200.
- 7. My position is up for re-election this year and I will put my name forward to be on the WGHA Board for another two-year term.
